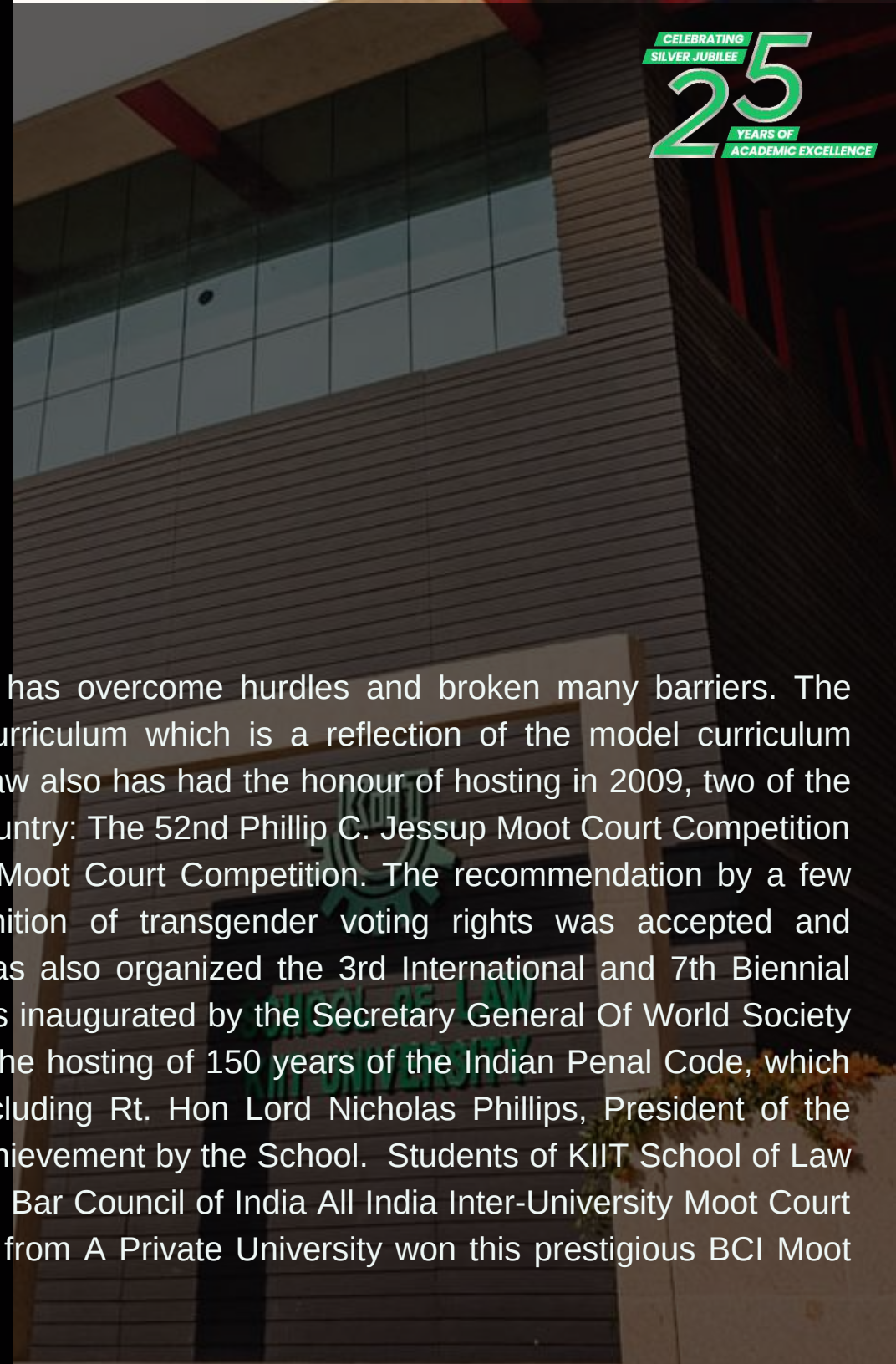

KIIT School of Law, in a span of 15 glorious years, has overcome hurdles and broken many barriers. The University has meticulously framed its rich course curriculum which is a reflection of the model curriculum proposed by the Bar Council of India. KIIT School of Law also has had the honour of hosting in 2009, two of the most prestigious moot court competitions held in the country: The 52nd Phillip C. Jessup Moot Court Competition and the First Bar Council of India (BCI) International Moot Court Competition. The recommendation by a few bright students to Election Commissions for recognition of transgender voting rights was accepted and implemented in the year 2009. KIIT School of Law has also organized the 3rd International and 7th Biennial Conference of Indian Society of Victimology, which was inaugurated by the Secretary General Of World Society of Victimology, Prof (Dr.) Gerd Ferdinanad Kirchhoff. The hosting of 150 years of the Indian Penal Code, which was attended by several eminent legal dignitaries including Rt. Hon Lord Nicholas Phillips, President of the Supreme Court of the United Kingdom, was another achievement by the School. Students of KIIT School of Law created history at the national level by winning the 29th Bar Council of India All India Inter-University Moot Court Competition in 2013. This was the first time any team from A Private University won this prestigious BCI Moot Court Competition.

KIIT School of Law ever remains prepared for assimilating the change. There is a visible drift from ‘lawyer centric, provincial, labour intensive guild to a customer- focused, global, digitized industry’. The transition indicates mustering new skill sets with reflective predictions. The ‘legal trade’ is assuming new focus in all matters of business and technology intrinsically coupled with social life. ‘Legal Service Business’ is expanding. Legal education cannot miss the opportunity. Where ‘to do more with less’ is buzzing, the ‘standard to legal delivery’ has to meet the challenge. ‘Clients, demand efficient, predictive, cost-effective, accessible, scalable and agile delivery of legal services’.

Enabling beyond ‘knowledge of law’, the legal training is being moderated to a suite of skillsets – project management, data analytic, business basics, technical agility, and teaming. ‘Virtual experiential learning techniques’ came into force because of pandemic. They signal to what is called as learning ‘Law without Walls’ (LWOW – Michele DeStefano). This places a ‘new polarization for future of law’ to (1) create innovations at the intersection of law, business and technology, that solve real problems and market needs; (2) hone skills (Lawyer Skill Delta, Destefano); and (3) build the lawyer-client dynamic and promote conducive environment.

In the scheme of things, KSOL being aware of things, are in continuous process of building ‘partnership between all members of the legal ecosystem- corporate law departments, law firms, alternative legal service providers, and academics- to help modernize legal education’ and transmit effective education that cater to the next generation of legal professionals.

KSOL as a part of curriculum, is also in the process of initiating a series of ‘legal boot camps’ to expose students to interdisciplinary real life problem solving with an emphasis on clinician finish of skills.

KSOL in association with other constituent institutes of KIIT-KISS system provides an unique opportunity to its students. It augments global best academic ambiance and provides an unusual learning ecosystem. All the academic stakeholders deem it as a privilege of being part of the knowledge system and learning space.



1st KIIT National Moot Court Competition, 2013

The 1st KIIT University National Moot Court Competition, 2013, was our first initiative in organizing a national level moot court competition. It turned out to be very successful and encouraging. Twenty four teams participated with immense enthusiasm. The competition's objective was to nurture academic excellence amongst the students, and it was to our pleasure and honor to have a seven-panel bench for judging the final round of the competition. The competition was weaved around two moot problems, one for the preliminary and quarterfinal rounds and another problem for the semi-final and final rounds. The active participation of the teams was of great motivation to us in our decision to organize this moot competition in a slightly different format.

The final round of the event witnessed a stiff competition between National Law University, Bhopal, and Christ University, Bengaluru, and the success of the event encouraged us to host and organize the next edition of the moot in 2014.



2nd KIIT National Moot Court Competition, 2014

The 2nd edition of the competition upheld the essentials of the first National Moot Court Competition which was challenging in nature in terms of mooting, erudite judging, high stake prizes and great hospitality. At the same time, there were significant improvements based on our learning experience from the past edition. One of India's best known law firms, Nishith Desai Associates, drafted the problems for the competition, while SCC Online and Lawctopus also partnered with us in different capacities, Like the earlier edition, the competition had two problems - one for the preliminary and quarter final rounds, and another problem for the semi-final and final rounds. Participation by teams from across the country had increased substantially for this event and by the conclusion of the moot, KIIT University National Moot Court Competition had made a name for itself and had become a much awaited mooting event.

Before a panel of eminent judges like Hon'ble Justice Altamas Kabir, (Former Chief Justice of India), Hon'ble Justice Pinaki Chandra Ghose, Judge, Supreme Court of India, and other Hon'ble Justices of the Odisha High Court and Calcutta High Court, the grand finale witnessed some intense advocacy by Hidayatullah National Law University, Raipur, and Rajiv Gandhi National University of Law, Patiala, pleading on behalf of petitioner and respondent respectively. The immense success of the event encouraged us to conduct the 3rd Edition.



3rd KIIT National Moot Court Competition, 2015

The 3rd National Moot Court Competition witnessed an unprecedented 46 teams from across India who argued before the erudite judges, at a shot to earn prizes worth over 2 Lacs. The event took place from 18th September 20th September, 2015 and marked the beginning of our association with J. Sagar Associates. Mr. Zerick Dastur, then partner at JSA, gave the inaugural address by stressing upon the importance of mooting skills for law students. The knock-out rounds witnessed the advocacy skills of the budding lawyers with utmost perfection, which also involved the best adjudicating panels comprising of sitting High Court and District Court Judges, Senior Advocates, Legal Counsels and Academicians. The teams were assertive yet concrete in their approach with their persuasive contentions and convincing arguments. At the end of the Semi Finals, the two best teams, namely CMR Law College, Bengaluru and Campus Law Centre, Delhi University entered the finals.

Hon'ble Justice Altamas Kabir (Former Chief Justice of Supreme Court of India) chaired the Finals along with a panel consisting of Hon'ble Justice Ruma Pal, former Judge of Supreme Court; Hon'ble Justice Indira Banerjee, Judge, Calcutta High Court; Mr. U.K. Chaudhary, Sr. Advocate, Supreme Court of India and Mr. Somasekhar Sundaresan, Partner at J Sagar Associates.



4th KIIT National Moot Court Competition, 2016

In continuation of our collaboration with J Sagar Associates, the 4th edition of the National Moot Court Competition witnessed a participation of 56 teams from all across the country. Various national law schools and top private universities battled it out for the ultimate prize money of 2 lakhs rupees. The event was organized from 16th to 18th September, 2016. The inaugural address was given by Hon'ble Justice (Retd.) A. S. Naidu which enlightened the participants about a lawyer's core values and professional perseverance. The teams were put in front of a panel consisting of sitting High Court Judges, Senior Counsels, and Senior Partners & Associates from top-tier law firms of the country. The finals witnessed teams of School of Law, Christ University & School of Excellence in Law, Chennai, pitted against each other.

The Final was chaired by a panel consisting of Hon'ble Justice Pinaki Chandra Ghosh, Judge, Supreme Court of India, Hon'ble Justice Sanjib Banerjee, Judge, Calcutta High Court, Hon'ble Justice (Retd.) S.J. Mukhopyadhay, Chairman, National Company Law Appellate Tribunal and Mr. Somasekhar Sundaresan.



5th KIIT National Moot Court Competition, 2017

After the unprecedented success of the previous edition, the 5th edition was a much anticipated event among the moot court fraternity. The problem, drafted by J. Sagar Associates, was based on competition law. The preliminary rounds witnessed teams putting up a tough fight against each other. However, only eight teams could proceed into the quarter final rounds. During the Quarter-final Rounds, the teams argued in the presence of Senior Advocates and academicians, who tested the erudite participants to the limit. However, only the unfathomable four could proceed to the Semi-Final Rounds where sitting High Court Judges tested their resolve. Ultimately Amity Law School Delhi and Christ University were pitted against each other for the Finals.

Ghose, (Retired), Supreme Court of India; Hon'ble Justice S.J Mukhopadhyaya, Supreme Court of India (Retired); Hon'ble Justice A.S Naidu, Odisha High Court (Retired); Mr. Pramod Kumar Singh, Advisor, Competition Commission of India; Mr. Ashish Ahuja, Managing Partner, Wadia Ghandy & Co., Mumbai; Mr. Sujit Ghosh, Partner, Advaita Legal, Mumbai and Mrs. Shabnum Kajiji, Partner, Wadia Ghandy & Co., Mumbai.



6th KIIT National Moot Court Competition, 2018

Enthused by the success of five magnanimous events, the 6th KIIT National Moot Court Competition was yet another successful event. The subject matter of the competition revolved around Arbitration. The problem drafted by J. Sagar Associates, Mumbai, intrigued many young minds, and the event saw a participation of 44 teams from all across the country. The judge-pool for the preliminary and qualifying rounds of the competition saw practitioners from High Courts across the country, academicians from the best law schools and senior associates from top firms like Wadia Ghandy & Co., Dua Associates, and many more. After a panel of five judges testing their knowledge, resolve, and demeanor, the teams representing SASTRA University and Rizvi Law College came out as finalists for the competition.

The Finals Bench comprised Hon'ble Justice Sanjib Banerjee, Calcutta High Court; Mr. Surya Prasad Misra, Advocate General, Odisha High Court; Mr. Somasekhar Sundaresan; Mr. Siddharth Datta, Partner, Shardul Amarchand Mangaldas and Prof. Indrajit Dube, Professor, Rajiv Gandhi Institute of Intellectual Property Laws, IIT Kharagpur. The Valedictory Ceremony witnessed Hon'ble Justice Debabrata Dash, Odisha High Court share his feedback on the final rounds and felicitate the winners of the competition.



7th KIIT National Moot Court Competition, 2019

In continuation of its six preceding events, the 7th KIIT National Moot Court Competition was also an enthralling affair from the beginning to the end. The event drew its crucial subject matter from Constitutional Law. It was formulated by Zerick Dastur, Founder and Proprietor, Zerick Dastur, Advocates and Solicitors. This raised the game's stakes and provided a thrilling match amongst the 42 contenders from different universities spanning across the nation. The preliminary and qualifying sessions witnessed esteemed line up of judges ranging from academicians, senior associates at top-tier firms to High Court and Supreme Court Practitioners to add flavor and expertise to the competition. The 8th KIIT National Moot Court Competition finally ended magnanimously and was a huge success after three days of arduous work thanks to the efforts of all the organising committee members, the faculty members who supported the committee, all the students who volunteered for the event, and all the amazing participants.
